The purposes of this study are to know the kinds of modal auxiliary verb and the function used in City of Heavenly Fire Novel written by Cassandra Clare. This study is descriptive qualitative research and object discussed about City of Heavenly Fire Novel written by Cassandra Clare. The data collection techniques are observation and literature review. Data analysis is to analyze sentences that use modal auxiliary verbs in the novel. The research findings are (1) modal auxiliary verb "could" and "would" mostly used in City of Heavenly Fire Novel, the use of modal auxiliary verbs "could" and "would" is 62% more than the use of modal auxiliary verb "will" and "can"; (2) The functions of modal auxiliaries are expressing present and past ability, expressing expectation, requesting action, requesting action, requesting permission, requesting permission, expressing preference, expressing present need or lack of need, expressing past need or lack of need, expressing advice, expressing advice about the past (action not taken), expressing present and past possibility, and expressing probability.

1. INTRODUCTION

Language means of communication and in this communication it's necessary to use a tense, tenses are a grammatical category that emphasizes the use of verbs in relation to the timing of their use. In the use of language has several sentences, to make a sentence in English it is very important to know the types of verbs and one form of the verb is an auxiliary verb. Sriyatun (2018: 2) says that, "in the context of English grammar, teaching auxiliaries are very important because auxiliaries are one of the parts of speech that accompany the main verb in order to fulfill the grammatical requirement of the correct sentence. To make a good sentence is required the correct structure of sentence, such use the auxiliary verb correctly". "Grammar is the central component of language and knowledge of grammar is one are a necessary for understanding language's linguistic system" (Ambar S., 2019: 2). "In grammar, a future tense is a verb form that generally marks the event described by the verb as not having happened yet, but expected to happen in the future" (https://en.m.wikipedia.org).

The use of auxiliary verbs can help to make sure when an activity is going to happen, to be sure to make a statement and to ask questions. Auxiliary verbs often appear in several sentences in English in a conversation, there are two types of auxiliary verbs, namely primary auxiliaries (to be, to do and to have) and modal

auxiliaries (can, could, may, might, must, shall, will, would, need, dare, used to). According Frank (1972: 94) says that, "modal auxiliary verbs are auxiliary verbs which add structural or semantic meaning to verbs that have more meaning to verbs such as ability, obligation, and possibility. Can, could, may, might, will, would, shall, should, ought to, must, used to, dare, need, be to, and be supposed to be called modal because they express the feelings, opinions or attitudes of the speaker towards what is said". The use of modal auxiliary verb isn't only found in everyday conversation or grammar books, but also in literary fields that produce literary works, such as dramas, short stories, and novels.

Bambang W. (2015: 69) in his journal states that, "there are three kinds of single sentences, among others: a) news sentences; b) interrogative sentence; and c) the command sentence. News sentences are sentences that support the 5 disclosure of events or incidents; interrogative sentence is a sentence that contains a request to obtain information from the giver of the unknown information; while a command sentence is a sentence that contains an order for someone to take the desired action". For the use of language in the novel, use it in accordance with the context of the sentence and according to the events that occur in the story such as direct sentences and indirect sentences. A direct sentence is defined as a sentence resulting from a quote from someone who is exactly the same as said, whereas an indirect sentence is a sentence that restates the content of a person's words without repeating the words that were said previously.

On this occasion, the analysis will focus on the use of modal auxiliary verb in interrogative and non-interrogative sentences, as well as comparing the structures in the various types of sentences used by Cassandra Clare in her novel story in terms of various pragmatic functions (for example prediction, intention, promise or suggestion and request) and will be discussed further in literary studies under the title The Analysis of Modal Auxiliary Verb Used In City of Heavenly Fire Novel Written By Cassandra Clare.

Aside from that, research descriptive qualitative is research that efforts to say existing problem solving based on data, presents the data, analyzes the data and interprets the data (Narbuko and Abu Achmadi, 1997: 44). the object that is discussed in this research, namely about City of Heavenly Fire Novel written by Cassandra Clare. The instruments of this research are preparing the novel of City of Heavenly Fire written by Cassandra Clare, stationery supplies, some papers or a book used for taking notes, and also checklist for collecting the sentence using modal auxiliary verb in the novel. The researcher is doing observation too by reading novel City of Heavenly Fire repeatedly to find modal auxiliary verb in the novel.

In qualitative research, data collection approach includes in-depth interview, document analysis, observation, and audiovisual materials analysis" (Creswell, 2012). In this research using data collection techniques, including:

1. Observation

One of the most common methods used in qualitative research is observation. Creswell (2012: 213) defines observation

"as the process of gathering open-ended, firsthand information by observing people and places at a research site". In addition, Wahyuni (2012) states that "observation provides better understanding and enrich our knowledge of current event or phenomena". This observation aimed to know the kinds of modal auxiliary verb used in City of Heavenly Fire written by Cassandra Clare and to know the function of modal auxiliary verb used in City of Heavenly Fire Novel written by Cassandra Clare.

26 Observation steps that be carried out by researchers in this study in stages

through are:

- 1. the first step with reading novel City of Heavenly Fire repeatedly;
- 2. the second steps with understanding the content of the novel;
- 3. then proceed to the third steps with finding out the sentences that is related to research problems;
- 4. next the fourth steps with writing down the significance notes about the function of each the sentence which is using modal auxiliary verb in the novel of City of Heavenly Fire written by Cassandra Clare and the different structure of each another:
- 5. and the last fifth steps with organizing data into several parts based on classifications.

According to Ary (2010:481) stated that "data analysis is the most

mysterious of complex and phase qualitative research. Data analysis in qualitative research is a time consuming and difficult process because typically the researcher faces massive amounts of field interview notes. transcripts, audio recordings, video data, reflections, or information from documents, all of which must be examined and interpreted". According Creswell (2014: 247), "during data analysis in qualitative research, the categorically organized chronologically, and reviews repeatedly". Because it's written material, thereby the data of this research are words, sentences which is using of modal auxiliary verb in the novel of City of Heavenly Fire written by Cassandra Clare. The source of primary data in this research is novel City of Heavenly Fire, while secondary data that supports primary data is obtained from literature review. After the researcher took the steps of collecting data, the next step is data analysis and data analysis in this research using descriptive qualitative analysis with sentences analysis which is using modal auxiliary verb in the novel of City of Heavenly Fire written by Cassandra Clare.

According to Sugiyono (2008: 245), "there are three activities to analyze data in descriptive qualitative research, including: data reduction, data display, and conclusion". This corresponds with the explanation of Miles, Matthew B. (1994: 10-11) which states that "data reduction refers to the process of selecting, focusing, simplifying, abstracting, and transforming

the data that appear in transcript notes. Through the data reduction the researcher focuses on the data that will be analyzed. Looking at displays helps us to understand what is happening and to do something-either analyze further or take action-based on that understanding. The conclusion is a form of thick description. The conclusion is the answers of the research problems that have been formulated". White and Marsh (2006: 34) add that "the emphasis in this step is always on answering the

research questions". Data analysis in this research using the theory of Warner, 2009 about the

functions of modal auxiliaries and the steps of data analysis including are:

- 1. Reading "the novel of City of Heavenly Fire written by Cassandra Clare" repeatedly
- 2. Exploring and describing the data.
- 3. Put end to data analysis in order to answer the statement of the research problems with interpreting the data based on the function of each the sentence which is using modal auxiliary verb in the novel of City of Heavenly Fire written by Cassandra Clare and the different structure of each another.
- 4. The final step is to conclude the results of the analysis.

3. FINDING AND DISCUSSION

3.1 FINDINGS

Kinds of modal auxiliary verbs include: can, could, may, must, shall, should, ought to, will, would. For the first step, the researcher has read the novel of City of Heavenly Fire written by Cassandra Clare repeatedly, then exploring and describing the data. In this research, the researcher has found modal auxiliary verb used in City of Heavenly Fire Novel written by Cassandra Clare covers as much as 286 matches for modal auxiliary verb "can", 596 matches for modal auxiliary verb "could", 27 matches for modal auxiliary verb "may", 77 matches for modal auxiliary verb "must", 34 matches for modal auxiliary verb "shall", 143 matches for modal auxiliary "should", 17 matches for modal auxiliary verb "ought to", 359 matches for modal auxiliary verb "will", 443 matches for modal auxiliary verb "would". Due to the large number of findings of modal auxiliary verb used in City of Heavenly Fire Novel Written by Cassandra Clare that reach more than 500 so that it is not possible for researchers to write down the sentences used one by one, samples will be taken for each of modal auxiliary verb used as many as 3 sentences.

Based on the data above, it shows that modal auxiliary verb "could" and "would" most used in City of Heavenly Fire Novel Written by Cassandra Clare, this proves that in writing the story on City of Heavenly Fire Novel Written by Cassandra Clare tells a story in which the

sentences are in the past tense. On the other side of storytelling, modal auxiliary verb "will" and "can" most used in City of Heavenly Fire Novel Written by Cassandra Clare are also most used, this proves that in writing the story, tells a story in which the sentences are in the present tense. Based on these data when compared between the use of present tense and past tense, the use of modal auxiliary verbs "could" and "would" is 62% more than the use of modal auxiliary verb "will" and "can". From this comparison, shows that in the writing of the story on City of Heavenly Fire Novel Written by Cassandra Clare, City of Heavenly Fire Novel writers today mostly tell stories from the past. In addition after reseacher had read City of Heavenly Fire Novel repeatedly, modal auxiliary verb "will" and "can" are more used in sentences that are written as direct sentences.

Based on sample in the table above, we found use of modal auxiliary verb "must" used in City of Heavenly Fire Novel written by Cassandra Clare with function as a necessity or command, an indisputable certainty, a belief about what is being thought. Next based on sample in the table above, we found use of modal auxiliary verb "shall" used in City of Heavenly Fire Novel written by Cassandra Clare with function as express a wish, ask for a certainty that will be done, a hope in the future. Next based on sample in the table above, we found use of modal auxiliary verb "should" used in City of Heavenly Fire Novel written by Cassandra Clare with function as shows suggestions for an event, suggestion to do something, give someone advice.

Based on sample in the table above, we found use of modal auxiliary verb "ought to" used in City of Heavenly Fire Novel written by Cassandra Clare with function as a necessity that doesn't happen, showing an inappropriate feeling, advice to someone about an attitude. Next based on sample in the table above, we found use of modal auxiliary verb "will" used in City of Heavenly Fire Novel written by Cassandra Clare with function as question a doubt about something, make sure something is certain, the question between sure and not. And the last based on sample in the table above, we found use of modal auxiliary verb "would" used in City of Heavenly Fire Novel written by Cassandra Clare with function as something that would have been done in the past, convince something that will be done in the past, express an opinion to others in the past.
